### WHO KILLED THE BOXER, PAT HUDSON?

## The Story

#### Some one in the crowd shouted out "Who killed the boxer Pat Hudson?"

<u>The referee</u> replied: "Not I, surely not! Do not point your finger at me. Of course, I could have stopped the fight at the eighth round. In that case, Pat might not have died.

But then, the public would have shouted and howled, and accused me of cheating them. It's so sad he died; but you know, it wasn't my fault. I did nothing to him."

The angry and greedy crowd whose shouts had rocked the stadium said: "It's a shame that Pat died! He was such a good man. All we wanted was to watch a good fight. We never wanted him to die; far from it. We didn't' kill him. No! No! Do not blame us!"

<u>Hudson's Manager said</u>: "It's very painful for me to speak of Pat's death. It's so sad to think of his wife and kids. I took it for granted that he was in good physical shape. If he wasn't fit for the fight, he was big enough to let us know. Ii was his mistake. No! You cannot blame me for his death. I am innocent."

The men at the betting booth said: "No. no." We have nothing to do with his death. We did nothing against him. We had not even shouted or cheered. He was such a promising boxer! It's not our fault."

And the press reporter Not I! I am completely Innocent of his death. I just was watching the game to report the fight in the morning papers. I was doing my job. Surely, Pat's time was up!

Ad the boxer who knocked him down said: "Not I! I did not kill him! I am not a murderer. I am a respectable man. I am just a sportsman. It's true that I struck him, but, of course, I did everything according to the rules of the game. I played a fair game! No one can blame me. Do not call me a "murderer" or "man slaughterer". It was Pat's luck, his destiny, his fate. It was the will of God."

### POINTS FOR REFLECTION AND DISCUSSION

- 1. What's the main thrust of this story? Explain.
- **2.** Have you ever come across similar tragic, painful, unjust, shattering incidents,- *minor or major ones* like the one in the boxer's death story, taking place in your school days, college, place of work, family or in our society at large? Mention them.
- 3. How and why do such situations arise?
- **4.** Who is answerable for the sufferings, the injustices and evils obtaining all around us? Yes, even within our families, institutions and neighborhood?
- **5.** Who and what are their causes?
- **6.** If we are part and parcel of our social set up we live in, why and how de we disclaim all responsibility for the evils and injustices of a society we are part thereof? Explain.
- 7. Can we, should we do something to stop or at least to lessen such social evils, sufferings and injustices? How? Where to start? Give Instances.
- **8.** Have you ever felt guilty for not helping someone who was unjustly treated or suffering? Explain.
- **9.** What could you have done for him? Why did you not do that?
- **10.** Did you ever feel that you too were a victim of social prejudices and injustices? How? Give instances.
- 11. Have you ever felt let down by the members of your family, friends and neighbors? Give instances. What could they have done for you that they never did?
- **12.** Are you really and honestly prepared to do for others what you expect others do for you?
